SUMMARY:

In February, Duval County's occupancy rate reached 73.4%, indicating a stabilization and gradual normalization of the tourism industry in Florida post-COVID. However, it's noteworthy that other key areas like Daytona, Tampa, and St. Johns County experienced larger losses in occupancy during the same period. Despite the challenges faced by some regions, Duval County's average daily rate (ADR) showed promising growth, increasing by nearly \$1. However, we did observe a loss in room revenue, totaling approximately \$900,000.

One significant highlight was the downtown area, which demonstrated growth across all three STR metrics. This suggests a return to our previous business mix, with downtown experiencing an uptick in occupancy, including an increase in group bookings. Conversely, the beaches hotels encountered the most significant decline in occupancy at -9.6%, coupled with a 2.7% decrease in ADR, making it the area with the highest loss percentage for February.

Looking at the year-to-date figures, our occupancy stands at 69.6%, reflecting a change of -3.8% compared to the previous year. Despite this, there was a 1% growth in ADR, reaching \$115.69. However, room revenue is down by 2.1% from last year, resulting in a loss of \$1.9 million year to date.
